On February 26, 2019, the Board accepted the initial award from the U.S. Department of Homeland Security, through the Florida Division of Emergency Management for the Orlo Vista/Westside Manor Project. On January 28, 2020 the Board accepted amendment No. 1; on November 2, 2020, the Board accepted amendment No. 2; and, then on May 18, 2021, the Board accepted amendment No. 3, which extended the project period to September 30, 2021.

The U.S. Department of Homeland Security, through the Florida Division of Emergency Management has now awarded amendment No. 4 in the amount of \$829,229, reducing the award total by \$27,538 and extending the project period to March 31, 2022. This subaward is for the improvement of the Orlo Vista neighborhood drainage and includes design, permitting, and surveys.

On September 23, 2021, the Board approved an estimated budget for the Community Services Block Grant program in the amount of \$1,049,178. The U.S. Department of Health and Human Services, through the Florida Department of Economic Opportunity, has now awarded this subgrant in the amount of \$909,086. This subaward was approved by the Board on March 9, 2021 and represents a decrease of \$140,092.

With this funding, the Community Action Division will enhance and strengthen family services programs for low-income families, youth, and seniors to assist in empowering them to become self-sufficient. The grant period for this subaward is October 1, 2020 through September 30, 2023.
