## **REMARKS:**

The Orlando United Assistance Center (OUAC) currently occupies a small County-owned building at 507 East Michigan Street (Site) pursuant to the Orlando United Assistance Center License Agreement approved by the Board on August 23, 2016, as renewed in August 2017 and June 2018 (License).

This First Amendment to Orlando United Assistance Center License Agreement will provide for OUAC's continued use of the Site and extends the term of the License for 4 months and 9 days, setting the new expiration at December 31, 2019. Any further renewals shall only be granted by approval of the Board.

All other terms and conditions of the License shall remain in effect.

# FIRST AMENDMENT TO ORLANDO UNITED ASSISTANCE CENTER LICENSE AGREEMENT

THIS FIRST AMENDMENT TO ORLANDO UNITED ASSISTANCE CENTER LICENSE AGREEMENT (this "First Amendment") is made effective as of the date last executed below (the "First Amendment Effective Date") and entered into by and between ORANGE COUNTY, FLORIDA, a charter county and political subdivision of the State of Florida ("County") and HEART OF FLORIDA UNITED WAY, INC., a Florida non-profit corporation ("United Way").

### RECITALS

- A. County and United Way (collectively, the "Parties") entered into that certain "Orlando United Assistance Center License Agreement" approved by the Orange County Board of County Commissioners (the "BCC") on August 23, 2016, (the "Original Agreement") providing the terms and conditions upon which County granted United Way a non-exclusive license to enter upon and use the Property (as defined in the Original Agreement) for the purposes more particularly described in the Original Agreement.
- B. The Parties thereafter extended the term of the Original Agreement pursuant to that certain "Acknowledgement of Term Renewal for Orlando United Assistance Center License Agreement" last executed August 16, 2017 (the "First Renewal").
- C. The Parties thereafter further extended the term of the Original Agreement, as extended by the First Renewal, pursuant to that certain "Second Acknowledgement of Term Renewal for Orlando United Assistance Center License Agreement" dated June 19, 2018 (the "Second Renewal").
- D. The Second Extension Term (as defined in the Second Renewal) is set to expire on August 22, 2019.
- E. The Parties have agreed to further extend the term of the Original Agreement, as previously extended by the First Renewal and by the Second Renewal, (collectively, the "Agreement") and to make certain additional modifications to the Agreement.
- F. The Parties desire to enter into this First Amendment for the purpose of setting forth the terms and conditions of such extension and such additional modifications.

NOW, THEREFORE, in consideration of the foregoing recitals, the mutual covenants and agreements set forth herein, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

1. <u>Recitals.</u> The recitals set forth above are true and correct and are incorporated herein by this reference.

- 2. <u>Definition.</u> Defined (capitalized) terms used herein, but not defined herein, shall have the meanings given to such terms by the Agreement.
- 3. <u>Extension of Term.</u> The term of the Agreement is hereby renewed for one (1) additional term of four (4) months and nine (9) days, commencing August 23, 2019, and terminating December 31, 2019 (the "**First Amendment Term"**).
- 4. <u>Further Extensions</u>. For avoidance of doubt, and notwithstanding anything in the Agreement to the contrary, any further extensions of the Agreement, as amended by this First Amendment, (collectively, the "**Amended Agreement**") beyond the First Amendment Term shall only be granted by further written amendment to the Amended Agreement approved by the BCC. The second (and last) sentence of Section 2 of the Original Agreement is hereby stricken in its entirety.
- 5. <u>Effect; Conflicts</u>. Except as set forth in this First Amendment, all other terms and provisions of the Agreement are hereby ratified and confirmed and shall remain in full force and effect. In the event of any conflict between the provisions of this First Amendment and the provisions of the Agreement, the provisions of this First Amendment shall control.
- 6. <u>Counterparts</u>. This First Amendment may be executed in two or more counterpart copies, each of which shall be fully effective as an original, and all of which together shall constitute one and the same instrument. Signature pages may be detached from the counterparts and attached to a single copy of this document to physically form one document.
