Irrevocable Standby Letter of Credit (LOC) No. 70005189, issued May 3, 2021 by Truist Bank on behalf of Toll Bros Inc. in favor of Orange County in the amount of \$584,540, was approved by the Board of County Commissioners on June 8, 2021 and serves as the required security to guarantee compliance with the terms of the Utility Line Construction Reimbursement Agreement for Village I Phase 3 and the First Amendment to Utility Line Construction Reimbursement Agreement for Village I Phase 3. This LOC Amendment extends the expiration date from May 3, 2022 to May 3, 2023 and adds a condition to the LOC that it will automatically extend without amendment for 12 months from the expiration date or any future expiration date unless the County is notified that Truist Bank elects not to extend the LOC.
