Funding will allow for planning and implementation of the Upstream Model with Chapin Hall at the University of Chicago. The Upstream Model is a collaborative approach involving Orange County Public Schools and community-based partners, utilizing evidence-based practices with youth and families to prevent student homelessness and reduce school dropouts. The grant period is from September 30, 2022 through September 29, 2023.
