ACTION REQUESTED:

Approval to award Invitation for Bids Y23-1032-TF, Staff Augmentation – Permit Analysts Building Safety to the low responsive and responsible bidder, Sunshine Enterprise USA, LLC, in the estimated amount of \$461,000 for a one-year term. Further request Board authorization for the Procurement Division to renew the contract for four additional one-year terms.

The Business Development Division evaluated the **5 bids** submitted for this project. Two of the bidders are Minority/Women Business Enterprise (M/WBE) firms. At the time of bid opening at least 7 firms were certified at the prime level in the scope of service. The **two** Orange County Certified Minority/Women Business Enterprise firms **were not within 7%** of the low bid for bid awards greater than \$100,000 to \$5,000,000 Hence, the bid preference program in accordance with the County's M/WBE Ordinance, Section 17-324 cannot be applied.
