## COMMON AREA

THIS SECOND AMENDMENT TO MAINTENANCE AGREEMENT PLAZA INTERNATIONAL COMMON AREA (the "Amendment") is entered into by and between ORANGE COUNTY, FLORIDA ("County"), a charter county and political subdivision of the State of Florida, and DBC-PI DEVELOPMENT, LLC, a Florida limited liability company ("DBC-PI").

### WITNESSETH

**WHEREAS**, pursuant to Chapter 125.01(1), Florida Statutes, the County has established a Municipal Service Taxing Unit / Benefit Unit (MSTU/BU) in an unincorporated area of Orange County, Florida, known as Plaza International; and

**WHEREAS**, the County has previously contracted with DBC-PI to provide maintenance services within the MSTU/BU for the non-paved road rights-of-way and public pedestrian and utility easements, most recently in an agreement dated June 23, 2020, as amended by that certain First Amendment to Maintenance Agreement Plaza International Common Area effective as of June 2, 2025 (together, the "2020 Agreement"); and

**WHEREAS**, the 2020 Agreement, by its terms, will expire on June 2, 2026, unless otherwise extended by the parties; and

**WHEREAS**, the County and DBC-PI desire to extend the 2020 Agreement.

**NOW, THEREFORE**, in consideration of these premises, the mutual covenants and agreements set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the County and DBC-PI hereby agree as follows:

### AGREEMENT

1. **RECITALS.** The above recitals are true and correct and are hereby incorporated as a material part of this Amendment by this reference.

2. **AMENDMENT TO 2020 AGREEMENT.** The 2020 Agreement is hereby further amended as follows, with deletions shown as ~~strikethroughs~~ and additions underlined:

(i) **Section 3. Terms of Services.** The term wherein DBC-PI shall provide the aforesaid Maintenance services shall begin anew on the effective date of this Maintenance Agreement (the "Renewal Date"), and unless extended pursuant to this Agreement, the term shall terminate ~~six (6)~~ seven (7) years after

the Renewal Date.

(ii) Section 15. Termination of Agreement, Rights of Renegotiations.

(a) This Agreement shall terminate ~~six (6)~~ seven (7) years after the Date (the "Termination Date") unless sooner for cause by either party, or as herein provided.

3. **REMAINDER OF 2020 AGREEMENT UNCHANGED.** Except as otherwise set forth herein, the remainder of the 2020 Agreement shall remain unchanged and in full force and effect.

4. **AMENDMENT/TERMINATION.** This Amendment may be amended or terminated only by express written instrument approved by County and DBC-PI.

5. **APPLICABLE LAW.** This Amendment and the provisions contained herein shall be construed, controlled, and interpreted according to the laws of the State of Florida.

6. **EFFECTIVE DATE.** This Amendment shall become effective on June 2, 2026, upon the later of the date of execution by County or the date of execution by DBC-PI.

7. **COUNTERPARTS.** This Amendment may be executed in any number of counterparts, each of which shall be deemed original, but all of which shall constitute one and the same agreement.



### DRAINAGE IMPROVEMENTS AND MAINTENANCE

THIS SECOND AMENDMENT TO MAINTENANCE AGREEMENT PLAZA INTERNATIONAL DRAINAGE IMPROVEMENTS AND MAINTENANCE (the "Amendment") is entered into by and between ORANGE COUNTY, FLORIDA ("County"), a charter county and political subdivision of the State of Florida, and DBC-PI DEVELOPMENT, LLC, a Florida limited liability company ("DBC-PI").

### WITNESSETH

**WHEREAS**, pursuant to Chapter 125.01(1), Florida Statutes, the County has established a Municipal Service Taxing Unit / Benefit Unit (MSTU/BU) in an unincorporated area of Orange County, Florida, known as Plaza International, for Management of Drainage Improvements and Maintenance; and

**WHEREAS**, the County has previously contracted with DBC-PI to provide maintenance services within the MSTU/BU, most recently in an agreement dated June 23, 2020, as amended by that certain First Amendment to Maintenance Agreement Plaza International Drainage Improvements and Maintenance, effective June 2, 2025 (together, the "2020 Agreement"); and

**WHEREAS**, the 2020 Agreement, by its terms, will expire on June 2, 2026, unless otherwise extended by the parties; and

**WHEREAS**, the County and DBC-PI desire to extend the 2020 Agreement.

**NOW, THEREFORE**, in consideration of these premises, the mutual covenants and agreements set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the County and DBC-PI hereby agree as follows:


