

#### Re: Orange County Future Land Use Amendment request 2020-2-A-2-1

We, the undersigned residents of Clarcona Rural Settlement, strongly oppose this request by Bailey's Real-Estate and Terra-Max Engineering, Inc because it is a Planned Development for <u>Commercial</u> use:

- 1) It does not support existing residential uses, and
- 2) Consists of high density rental housing units situated in the heart of the Rural Settlement of Clarcona

We argue that this request for variance is in direct opposition to the intent of Orange County's Comprehensive Pan for Future Land Use 2010-2030 to protect the Rural Settlement of Clarcona. (See discussion below)

We thereby request that the Orange County Local Planning Agency, Planning and Zoning Commission and the Board of County Commissioners <u>uphold and protect</u> the land use plan developed by the Orange County Government and <u>deny</u> this use and density variance request.

#### Discussion:

Neighborhood commercial uses in Rural Settlements

- A. FUTURE LAND USE Policy 6.2.9 states "only commercial and office uses that will support existing residential uses, shall be permitted in Rural Settlements. The <u>scale and intensity</u> of commercial and office uses must be compatible with the development pattern of the existing Rural Settlement."
- B. FUTURE LAND USE Policy 6.2.10 states
  - a. "...these [commercial] uses shall be located to serve the residents of the rural area and not primarily to attract "pass-by" trips; and
  - b. These uses shall contain retail and personal services <u>intended to serve the immediate</u> <u>population."</u>

We argue that the existing Clarcona RS residents are not the primary customer for the use of this ALF development. This was evident at a 11/05/2020 community meeting held by Commissioner Moore where the overwhelming majority of the attendees in support of the project DO NOT reside within the Rural Settlement. This development would rely on customers outside of the rural area to maintain their business.

- 1) High Density
  - A. FUTURE LAND USE Policy 6.2.2 states "Every effort shall be made to preserve the <u>existing</u> <u>character</u> of the Tangerine, **Clarcona**, Christmas, Zellwood and Gotha Rural Settlements as part of Orange County's heritage and historic preservation."
  - B. FUTURE LAND USE Policy 6.2.5 states "The permitted densities and intensities of land use with the Rural Settlement shall maintain their <u>rural character</u>."
  - C. FUTURE LAND USE Policy 6.2.7 states "All other amendments to residential densities of the Rural Settlement shall not allow residential development to exceed one (1) dwelling unit per acre."

Orange County's Comprehensive Plan 2010-2030 charges the County Planners to preserve the 2010 existing character of Clarcona. Therefore, if approved, the rezoning of 47 acres of RS 1/5 and RS 1/2 in the heart of the community to commercial rental property of the currently proposed approx 5/1 (180 living units in 47 acres) does not preserve the character of 2010 nor the rural character.

We are Opposed to the Land Use Change - Amendment 2020-2-A-2-1- being requested by Terra Max Engineering on behalf of Bailey Properties. Honoring and preserving the integrity of the existing Orange County Rural Settlement Specification is critical.

We accept that changes will occur in this growing community, but removing and/or destroying the Rural status by creating a Commercial Development is completely unacceptable. Smart growth includes recognizing what makes Communities special. To create another commercial development, an ALF that could be built in another appropriately zoned location, is in No way Smart. Too many Orange County Rural Communities have been destroyed by sprawl.
