RECOMMENDATION:

Selection of KZF Design LLC dba KMF Architects to provide Design Services for the Orange County Convention Center West Building Chapin Theater Finishes and Stage Upgrades, Request for Proposals, Y23-809-SH.

Request the Board to authorize the Procurement Division to negotiate and execute a contract with a not-to-exceed budget of \$364,000.

The proposal was evaluated by the Procurement Committee on January 25, 2023. Commissioner Michael Scott was assigned to the Procurement Committee.

PURPOSE:

This contract will provide final design and construction plans for the Orange County Convention Center West Building Chapin Theater Finishes and Stage Upgrades. This project is located in District 6.

FUNDING:

Funding is available in account number 4430-035-0966-49-6210.

DISCUSSION:

The existing stage was modified for a permanent Broadway type production show over 20 years ago, and due to the extent of those modifications coupled with its many years of operation, is in need of replacement. The existing orchestra pit cover is difficult, time consuming, and hazardous for staff to remove. The carpet, seating, and wall panel fabric are all original to the Chapin Theater, which opened in 1996.

These finishes need to be replaced as they are unrepairable and have exceeded their useful life and no longer provide for the guest experience of a world class convention center for the clients attending Orange County Convention Center events.

Two proposals were received in response to this Request for Proposals (RFP). The proposal from LED AMP Energy Corp. was deemed non-responsive for failing to submit required documents per the RFP. The Procurement Committee evaluated the proposal in accordance with the criteria set forth in this RFP. The Procurement Committee's consensus scores are attached.
