ACTION REQUESTED:

Approval of Amendment No. 5, Contract Y18-804, Professional Services for Utilities Operations Center-East Project, with Rhodes + Brito Architects, Inc. the amount of \$357,420.42, for a revised contract amount of \$2,420,288.60

PROCUREMENT:

This amendment will add gopher tortoise relocation assistance services which includes gopher tortoise survey, permitting, relocation, and exclusion fence installation. It also adds construction administration services for seven additional months to reach substantial completion at 19 months and final completion at 21 months. This project is located in District 4.

APPROVALS:

The Utilities Engineering Division concurs with this recommendation.

DISCUSSION:

The Board authorized the selection of Rhodes + Brito Architects, Inc. on March 20, 2018 and authorized negotiation and execution of a contract by the Procurement Division provided that the contract does not exceed the budget amount of \$2,000,000. The contract was executed on February 20, 2019 in the amount of \$1,969,160.47.
