West Orange Trail Plant Street Bridge Grant - Agreement No. T1813

Amendment No. 1

The Florida Department of Environmental Protection (FDEP) is requesting that Orange County Government approve a revision to West Orange Trail Wooden Bridge Replacement grant agreement. The existing agreement was fully executed on June 13, 2019; however, the scope needs clarification to ensure all construction costs are reimbursable when the time comes for the County to submit for reimbursement to the State. The change will replace "Bridge demolition and renovation of 14' x 150' (+/-10%) hard-surface trail" with "Demolition of wooden bridge, construction of 14' x 60' (+/-10%) precast concrete bridge and renovation of 14' x 150' (+/-10%) asphalt trail" in the Work Plan.

FDEP requires the approved amendment prior to issuing the County a Notice to Proceed for construction. The amendment outlines the change in scope and the agreement demonstrates what was previously approved by the Board.

- 2) All other terms and conditions of the Agreement remain in effect. If and to the extent that any inconsistency may appear between the Agreement and this Amendment, the provisions of this Amendment shall control.

ATTACHMENT 3-A REVISED GRANT WORK PLAN RECREATIONAL TRAILS PROGRAM (RTP)

SUMMARY: The Grantee will complete the Project Element(s), which were approved by the Department through the RTP Application Evaluation Criteria, pursuant to Chapter 62S-2, Florida Administrative Code (F.A.C.) and the FHWA Recreational Trails Program Interim Guidance Manual. Any alteration(s) to the Project Element(s) defined in the Grant Work Plan resulting in a change in the total point score of Grantee's Application as it appears on the RTP Advisory Committee's Priority List for FY2017-18 is considered a significant change, must be pre-approved by the Department, and requires a formal Amendment to this Agreement. All work must be completed in accordance with laws, rules, and guidance including, but not limited to: local, state and federal laws, the approved Project plans, all required permits, the Florida Building Code and, as applicable, the Manual of Uniform Minimum Standards for Design, Construction and Maintenance for Streets and Highways ("Florida Greenbook"). Prior to the Department issuing a Notice to Proceed to the Grantee, as specified in Attachment 6. Program Specific Requirements, the Department must receive evidence of and have approved all Deliverables in Task 1.

The Department will designate the Project complete upon receipt and approval of all Deliverables and when Project site is open and available for use by the public for outdoor, recreation purposes. The Department will retain ten percent (10%) of the Grant Award until the Grantee completes the Project and the Department approves the Completion Documentation set forth in paragraph 62S-2.075(7)(e), F.A.C. The final payment of the retained ten percent (10%) will be processed within thirty (30) days of the Project being designated complete by the Department.

For the purpose of this Agreement, the terms "Project Element" and "Project Task" are used interchangeably to mean an identified facility within the Project.

The project is located at E Division St, Winter Garden, FL 34787 and is a Non-Motorized/Diverse Use Trail.

BUDGET: Reimbursement for allowable costs for the Project may not exceed the maximum grant award amount outlined below. Required match will be provided by cash or inkind services as set forth in subsection 62S-2.071(4), F.A.C. Grantee shall maintain an accounting system that meets generally accepted accounting principles and will maintain financial records to properly account for all Program and matching funds. The total estimated Project cost provided below is based on the approved RTP Application. A detailed Project cost analysis will be provided in the Deliverables for Task 1, prior to the Department issuing the Notice to Proceed. All final Project costs shall be submitted to the Department with the payment request.
