SUBJECT: Ratification of Amendment No. 4, Contract Y22-131-RM, Biosolids

Management - South Water Reclamation Facility

### **ACTION REQUESTED:**

Ratification of Amendment No. 4, Contract Y22-131-RM, Biosolids Management – South Water Reclamation Facility, with Revinu, Inc., in the amount of \$1,300,000, for a revised estimated contract amount of \$2,398,042 for Option Year 1.

## **PROCUREMENT:**

This amendment adds funds needed to meet the biosolids hauling needs of the South Water Reclamation Facility through March 19, 2024. During Option Year 1, Revinu, Inc. indicated they are no longer able to access approved Florida Department of Environmental Protection land application sites due to nutrient limitations. As a result, the Utilities Department amended the contract to add a line item for disposal at JED Landfill with an additional cost of \$40 per ton. Consequently, additional funds are needed to continue services without interruption. These actions are imperative to ensure the health and public safety of County residents and County employees and to maintain regulatory compliance.

### **FUNDING:**

Funding is available in account number 4420-038-1351-3197.

#### **APPROVALS:**

The Water Reclamation Division concurs with this recommendation.

### REMARKS:

On March 8, 2022, the Board authorized award of Contract Y22-131-RM to Revinu, Inc., in the amount of \$1,075,958 for the base year, with the option to exercise years one and two.

Previous contract amendments are as follows:

- Amendment No. 1: Renewed the contract for Option Year 1, for the period of March 20, 2023 through March 19, 2024, in the estimated annual contract award amount of \$1,098,042.
- Amendment No. 2: Added Line Item 2: Disposal Fee of \$40 per Ton for biosolids hauled from the Orange County South Water Reclamation Facility to be disposed at the JED Landfill, 1501 Omni Way, St. Cloud, FL 34773, up to 6 loads daily, 5 days per week during the landfill's receiving hours Monday through Friday, 6:00 AM to 2:30 PM.
- Amendment No. 3: Modified the requirements contract provision in paragraph 25 of the special terms and conditions.
