RECOMMENDATION:

Selection of four firms to provide Supervisory Control and Data Acquisition (SCADA) Services, Request for Proposals Y19-198-AH, from the following firms, listed alphabetically:

Curry Controls Company DSI Innovations, LLC Infamation Technologies Group LLC Revere Control Systems, Inc.

Further request authorization for the Procurement Division to negotiate and execute four 3-year contracts within a cumulative budget of \$1,200,000. Further request authorization for the Procurement Division to renew the contract for two additional 1-year terms.

The proposals were evaluated by the Procurement Committee on August 21, 2019. Commissioner Betsy VanderLey was assigned to the Procurement Committee.

PURPOSE:

This contract will provide professional services for Supervisory Control and Data Acquisition (SCADA) planning, designing, and integration including subsystems such as electrical, instrumentation, servers, and network communications as they relate to the utility SCADA system.

DISCUSSION:

These services include, but are not limited to, engineering, maintenance, repair, refurbishment, programming, construction, and replacement of SCADA and related assets including control panels, programmable logic controllers, Human-Machine Interface software platforms, power systems, motor control equipment, instrumentation, server systems, network communication systems, and remote terminal units.

Selection of Firms, Request for Proposals Y19-198-AH, Supervisory Control and Data Acquisition (SCADA) Services

The Contractors will support the SCADA services of various divisions within Orange County Utilities, such as water production, pumping, and water reclamation.

Six proposals were received in response to this Request for Proposals (RFP). The Procurement Committee evaluated all responsive proposals received in accordance with the criteria set forth in the RFP. Per the RFP, the County reserves the right to make multiple awards based on the results. The County intends to award to two Siemens Solutions Partners and two Schneider Alliance Partners.

The proposers qualifying as Siemens Solutions Partners are DSI Innovations, LLC and Infamation Technologies Group LLC. The proposers qualifying as Schneider Alliance Partners are Curry Controls Company and Revere Controls Systems, Inc. The proposals received from Blackburn Controls, Inc. dba BCI Technologies and ControLogix, LLC are not being considered for award as these proposers were only certified as SCADA Integrators.
