The Orange County Environmental Protection Division has received an award from the U.S. Environmental Protection Agency for the EPA 103 Multipollutant Monitoring – Inflation Reduction Act program in the amount of \$365,500. These funds will allow Orange County Environmental Protection Division to upgrade aging air monitoring equipment, provide on-site training opportunities to staff, and support the County’s efforts with staying in compliance with National Ambient Air Quality Standards (NAAQS). The grant period for this award is from May 1, 2024 through April 30, 2029.
