The Orange County Sheriff's Office is requesting \$1,000 from the FY 2019 Law Enforcement Trust Fund for the following purpose:

Inside Out Jail Ministries, Inc. (ISO) - \$1,000. This organization works with inmates from all religious and cultural backgrounds inside the Orange County Jail. ISO places hundreds of men and women into substance-abuse programs locally. Their goal is to help inmates through the transition to living as productive citizens outside of jail.

ACTION REQUESTED: Approval for the Orange County Sheriff's Office

to spend \$1,000 from the FY 2019 Law Enforcement Trust Fund to provide an eligible contribution to Inside Out Jail Ministries, Inc.

PLEASE NOTE:

The Board voted to establish spending limits of 20% for this fund for contributions. At this point in the fiscal year, contributions represent 38% of the total expenditures; however, the restriction applies to total expenditures for the year, at year-end. The Sheriff's Office has stated that they monitor their expenditures, and that they will not exceed the 20% total for contributions.
