Department of Juvenile Justice Mandated Cost-Share

Approval of Payment Amount for FY 2021/2022

During the 2021-22 budget work sessions, the Board approved funding to cover the state-mandated Department of Juvenile Justice costs to Orange County. Based on Florida Statutes, Orange County is required to pay its annual percentage share of detention costs. These funds were placed in the Youth and Family Services Division budget to be disbursed as required. The amount from the State for FY 21-22 specifies \$2,635,578. However, we are requesting the amount of \$3,700,000. The difference is due to the State's fiscal year ending June 30, 2022, while the County's fiscal year ends September 30, 2022. The additional funds account for the extra three months and any additional changes the State may make for July 2022.

## FLORIDA DEPARTMENT OF JUVENILE JUSTICE

#### Dear County Representative:

In accordance with Chapter 2021-219, Laws of Florida, the Department is required to provide each county that is not a fiscally constrained county and that does not provide its own detention care for juveniles, with that county's annual percentage share and its individual portion of total shared detention costs for the state's fiscal year by July 15 of each year. For each county that is not a fiscally constrained county and does not provide its own detention care for juveniles, the individual county's portion of detention funding is calculated by multiplying its annual percentage share by 50 percent of the total actual shared detention costs. The annual individual portion is payable in 12 equal payments due on August 1 and the first day of each month thereafter until the annual amount is paid in full.

Fifty percent of the total actual shared detention costs for Fiscal Year 2020-21 (less costs for fiscally constrained counties, out-of-state youth, and county-operated detention) is \$46,522,146, and the total service days are 202,199 for the months of May 2020 through April 2021, the most recently completed twelvemonth period. The percentage of usage for each non-fiscally constrained county was derived by dividing the total number of service days for each county by the total number of service days for juveniles in all counties that are non-fiscally constrained during the period referenced above. That percentage is multiplied by the dollar value above to arrive at each county's annual share. Each county's annual share is then divided by twelve to determine the Fiscal Year 2021-22 monthly billable amount for that county. The enclosed Fiscal Year 2021-22 Secure Detention Cost Share spreadsheet shows the counties' annual and monthly invoice amount. Your July 2021 invoice is included with this correspondence and reflects the new monthly amount for your county as indicated on the enclosed spreadsheet. Invoice amounts are due and payable on the first day of each month for the preceding month's service.

Please note that, due to the COVID-19 pandemic, the total shared detention costs and service days observed during each respective period decreased relative to the previous period. Accordingly, and for subsequent years' budgetary purposes, the Department anticipates a return-to-normal cost structure to resume. Additionally, with the increased minimum wage compensation, costs may increase respectively.
