REMARKS:

Six bids were received in response to this Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. The bids from Mae Mancilla, LLC and Urgentcare Landscaping were deemed non-responsive for failure to submit required documents. Seasonal Effects LLC and Solscape Services, LLC were deemed non-responsible for failure to meet the required minimum reference requirements. Lawnwalker Services, Inc. has a satisfactory record of performance and is considered responsible. Prices have been determined reasonable compared to current contracted pricing. Therefore, award is recommended to Lawnwalker Services, Inc.
