### AVALON ROAD RCA - BCC PUBLIC HEARING

#### APRIL 11, 2023

Orange County is finalizing a Roadway Conceptual Analysis (RCA) for the widening of Avalon Road from U.S. 192 to Hartzog Road.


The improved road would provide four 12-foot-wide travel lanes, two in each direction, separated by a 22-foot-wide raised median. The improved corridor would also have a 6-foot-wide sidewalk on the east side of the road, and a 10-foot-wide shared-use path on the west side of the road.

The public will have an opportunity to provide comments at a public hearing before the Orange County Board of County Commissioners on Tuesday, April 11, 2023, at 9 a.m. (or shortly thereafter).

Orange County will not exclude from participation in, deny the benefits of, or subject to discrimination any person on the grounds of race, color, national origin, sex, age, disability, religion, income, or family status. 

## April is Fair Housing Month

April is Fair Housing Month, and Orange County joins the U.S. Department of Housing and Urban Development (HUD) in marking the 55<sup>th</sup> anniversary of the passage of the landmark Fair Housing Act, a component of Title VIII of the Civil Rights Act of 1968. This Act was passed by Congress and signed into law on April 11, 1968, by President Johnson, following the assassination of Dr. Martin Luther King on April 4, 1968. The theme for this year is “Choices For All Voices, Building An Equitable Future.”

The Fair Housing Act prohibited discrimination in the sale, rental, and financing of housing based on national origin, race, religion, and sex. It was strengthened in 1988 by an amendment adding administrative enforcement procedures and prohibiting discrimination based on disability and familial status. Orange County acknowledges the importance of this Act by establishing expanded rights under Chapter 22 of the Orange County Code. The Code promotes, “through fair, orderly, and lawful procedure the opportunity for each individual so desiring to obtain housing of such individual’s choice in Orange County without regard to race, color, religion, national origin, disability, marital status, familial status, lawful source of income, sex, sexual orientation, or actual or perceived status as a victim of domestic violence, dating violence, or stalking.”

This year’s theme, Choices For All Voices, Building An Equitable Future, supports the Act that demands equality in housing as a foundation on which aspirations can be achieved and affirms the role of the Fair Housing Act in challenging housing discrimination. We acknowledge the housing challenges that still remain, and we are committed to working collectively to find solutions. Though progress has been made, much remains to be done. Orange County is working on developing its new Analysis of Impediments to Fair Housing Choice, a five-year plan that identifies existing barriers to fair housing choice and proposes a set of actions to overcome those barriers.
