SPECIAL WARRANTY DEED FOR IMPROVEMENTS

(Wherever used herein the terms "Grantor" and "Grantee" include all the parties to this instrument and the heirs, legal representatives and assigns of individuals, and the successors and assigns of corporations, partnerships [including joint ventures], public bodies and quasi-public bodies.)

WITNESSETH:

THAT the Grantor, for and in consideration of the sum of TEN AND NO/100 DOLLARS (\$10.00) and other valuable consideration, the receipt and sufficiency of which is hereby acknowledged, by these presents does grant, bargain, sell, alien, remise, release, convey and confirm unto the Grantee all buildings, structures, fixtures, and other real property improvements of every kind and nature located on that certain land situate in Orange County, Florida, (collectively, the "Improvements") more particularly described as follows:

Lot 1, BURNHAM INSTITUTE FOR MEDICAL RESEARCH AT LAKE NONA PHASE 1, according to the plat thereof, recorded in Plat Book 73, Pages 40 through 42, inclusive, in the Public Records of Orange County, Florida (hereinafter, collectively referred to as the "Property").

Without limiting the generality of the foregoing, the Improvements include the bio-medical research facility presently known as the Sanford Burnham Prebys Medical Discovery Institute at Lake Nona, comprising approximately 170,000 square feet, the address of which is 6400 Sanger Road, Orlando, Florida 32827, together with all adjacent surface and subsurface infrastructure and utilities and all related on-site improvements, including parking, driveways, landscaping, hardscaping, signage, and irrigation.
