WHEREAS, among other things, Resolution authorized and directed Orange County and all appropriate departments, officers and employees of Orange County to proceed to take the necessary actions to acquire parcel numbers 1072, 8072, 7072A, and 7072B for roadway purposes by gift, purchase, eminent domain proceedings or otherwise;

WHEREAS, the Board of County Commissioners desires to make it clear that parcel 8072 is also being acquired to be used for the purpose of constructing a pedestrian bridge within the right-of-way;

WHEREAS, the Board of County Commissioners desires to amend Resolution to set forth this additional use.

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF
ORANGE COUNTY:

Section 1. Amendment to Resolution. Resolution, as approved on November 15, 2022, is amended by adding the words “including a pedestrian bridge” after the word “roadway” wherever the word “roadway” appears in Resolution. In all other respects, Resolution shall remain unchanged.

Section 2. Effective date. This Amendment to Resolution shall take effect on the date of its adoption.
