FIRST AMENDMENT TO THE PARKING LICENSE AGREEMENT

THIS FIRST AMENDMENT TO THE PARKING LICENSE AGREEMENT ("Amendment") is made and entered into as of the date last executed below (hereinafter referred to as the "Effective Date") by and between the **City of Orlando, Florida**, a municipal corporation organized and existing under the laws of the State of Florida ("City"), and the **Orange County, Florida**, a charter county and political subdivision of the State of Florida ("Licensee").

WHEREAS, the City owns fee simple title to the vacant property located on the northeast corner of the intersection of West Church Street and South Westmoreland Drive, having an address of 925 West Church Street, Orlando, Florida 32805 (Licensed Premises); and

WHEREAS, the Licensee operates a public health clinic at 832 W. Central Boulevard, Orlando, Florida 32805 (Health Clinic) and desires to use the Licensed Premises for employee parking; and

WHEREAS, the City and Licensee entered into a License Agreement dated June 21, 2022, (the "License Agreement") to permit short-term vehicle parking for the Licensee's employees and employees of the adjacent Orange County medical clinic; and

WHEREAS, the Licensee has requested an extension of the License Agreement, and the City and Licensee desire to amend the License Agreement to extend the term.

NOW, THEREFORE, for and in consideration of the mutual covenants, promises, terms, and conditions set forth herein, the receipt and sufficiency of which is hereby acknowledged, the City and Licensee agree to amend the License Agreement as follows:

1. The parties agree to amend the provisions of Section 3 of the License Agreement to read as follows:

<u>The original term of the License Agreement</u> was for a period of nine (9) months from the Effective Date of this License and ending on March 21, 2023. The term may be extended for an additional nine (9) months ending on December 21, 2023, or any portion thereof, by the mutual, written agreement of the parties.

2. The parties agree to amend the provisions of Section 4 of the License Agreement to read as follows:

<u>Reservation of Use by the City</u>. The Licensee's use of the Licensed Premises is limited to Monday through Friday during the hours of 7:00 A.M. to 6:00 P.M., unless other times are approved in writing by the City.

Additionally, the City hereby reserves the right to exclusively occupy and use the Licensed Premises:

1) After 6:00 P.M. Monday through Friday;

- 2) At all times on Saturday and Sunday;
- 3) On those dates where the City has provided 14 days' written notice to the Licensee of the City's intent to utilize the Licensed Premises; and
- 4) On those dates listed in Exhibit "B." On these dates all vehicles must be removed by 3:00 P.M. for previously scheduled events.
- 3. The parties agree that Exhibit "B" to the License Agreement shall be replaced in its entirety with Exhibit "A" to this Amendment.
- 4. Except as specifically amended herein, all other terms and conditions of the License Agreement remain in full force and effect.
