

AN ORDINANCE AFFECTING THE USE OF LAND IN ORANGE COUNTY; AMENDING CHAPTER 23 OF THE ORANGE COUNTY CODE ("IMPACT FEES") BY CREATING CERTAIN PROVISIONS FOR NEW EXEMPTIONS; AMENDING SECTION 23-98 IN ARTICLE IV, KNOWN AS THE "TRANSPORTATION IMPACT FEE ORDINANCE"; AMENDING SECTION 23-161 IN ARTICLE V, KNOWN AS THE "ORANGE COUNTY SCHOOL IMPACT FEE ORDINANCE"; AND PROVIDING AN EFFECTIVE DATE.
