ACTION REQUESTED:

Approval to award Invitation for Bids Y20-1059-KB, Safety-Toed Footwear, to the lowest responsive and responsible bidder, Safety Shoe Distributors LLP, for an estimated contract amount of \$110,683.05, for a one-year term. Further request authorization for the Procurement Division to renew the contract for four additional one-year terms.

PROCUREMENT:

This contract will provide safety shoes for employees countywide.

FUNDING:

Delivery orders will be issued on an as-needed basis.

APPROVALS:

The Utilities Department and Business Development Division concur with this recommendation.

REMARKS:

Two bids were received and evaluated for price, responsiveness, and responsibility. The lowest responsive, responsible bidder, Safety Shoe Distributors LLP, has the necessary manpower and equipment to perform this contract. Global Trading, Inc. was deemed non-responsive for not submitting all documents required in the solicitation. Global Trading, Inc. filed a timely protest. A protest review was conducted by the Procurement Manager, and she rendered the decision to deny the protest. No timely appeal was filed. Safety Shoe Distributors, LLP is the contractor currently performing this service, and the price for these services is considered reasonable and consistent with the previous cost for this service. Reference checks were conducted with favorable responses. Therefore, award is recommended to Safety Shoe Distributors LLP.
