ACTION REQUESTED:

Approval to award Invitation for Bids Y18-1056-AV, Lot Cleaning Services for Code Enforcement, to the following low responsive and responsible bidders by Lot in an estimated contract award amount for a 1-year term: Lot A to A.L.G. Landscaping and Concrete Work Inc. for \$406,658.50, Lot B to D3 Enviroscape, LLC for \$527,700, and Lot C to ABL Land Services, Inc. for \$697,850. Further, request authorization for the Procurement Division to renew the contracts for four additional 1-year terms.

PROCUREMENT:

To provide lot cleaning services for Code Enforcement as needed throughout Orange County.

FUNDING:

Funding is available in account 0001-068-3220-3197.

APPROVALS:

The Code Enforcement Division concurs with this recommendation.

REMARKS:

Eight bids were received in response to this Invitation for Bids and were evaluated for responsiveness, responsibility and price reasonableness. Lightning Commercial Cleaning Service, LLC, was deemed non-responsible due to insufficient equipment to perform services.

The solicitation limited award to a maximum of one geographical location per lot. Recommendation for award is made to the lowest responsive and responsible bidder, for Lot A, A.L.G. Landscaping and Concrete Work Inc., for Lot B, D3 Enviroscape, LLC, and for Lot C, ABL Land Services, Inc., who all meet the requirements of this solicitation.
