



# LEGAL DESCRIPTION:

A portion of Sections 9 and 16, Township 20 South, Range 27 East, Orange County, Florida, being more particularly described as follows: BEGIN at the northeast corner of the Southeast 1/4 of the Northwest 1/4 of said Section 16, said corner being a 3 inch round concrete monument; thence run S 89°16'24" W, a distance of 764.40 feet; thence run S 43°29'45" W, a distance of 587.71 feet to a point on the easterly right-of-way line of U.S. Highway No. 441, as recorded and described in Minute Book 6, Page 116, Public Records of Orange County, Florida; thence northwesterly, along said easterly right-of-way line, the following courses and distances; run N 35°55'47" W, a distance of 453.29 feet to a point of curvature of a curve, concave northeasterly, having a radius of 2734.93 feet and a central angle of 19°17'04"; thence run northwesterly, along the arc of said curve, a distance of 920.52 feet to a point; thence run N 73°21'17" E, a distance of 20.00 feet to a point on a non-tangent curve, concave northeasterly, having a radius of 2714.93 feet and a central angle of 10°59'58"; thence on a chord bearing of N 11°08'44" W, run 521.20 feet along the arc of said curve to a point; thence run S 84°21'15" W, a distance of 20.00 feet to a point on a non-tangent curve, concave easterly, having a radius of 2734.93 feet and a central angle of 05°35′50"; thence on a chord bearing of N 02°50'51" W, run 267.17 feet along the arc of said curve to the point of tangency thereof; thence run N 00°02'56" W, a distance of 841.98 feet to a point on the southerly right-of-way line of Terrell Road, as recorded and described in said Minute Book 6, Page 116; thence northeasterly, along said southerly right-of-way line, the following courses and distances; run N 74°42'04" E, a distance of 176.16 feet; thence run N 15°17'56" W, a distance of 10.00 feet; thence run N 74°42'04" E, a distance of 665.52 feet to a point on the north line of the Southeast 1/4 of the Southwest 1/4 of said Section 9; thence run N 88°55'35" E, along said north line, a distance of 1128.56 feet to a point on the north line of the Southwest 1/4 of the Southeast 1/4 of said Section 9; thence run N 88°50'26" E, along the north line of the Southwest 1/4 of the Southeast 1/4 of said Section 9, a distance of 1311.20 feet; thence run S 00°23'55" E, a distance of 458.01 feet; thence run N 89°02'53" E, a distance of 17.80 feet to a point on the east line of the Southwest 1/4 of the Southeast 1/4 of said Section 9; thence run S 00°23'55" E, along said east line, a distance of 862.81 feet to a point on the north line of the Northwest 1/4 of the Northeast 1/4 of said Section 16; thence run S 89°19'01" W, along the north line of the Northwest 1/4 of the Northeast 1/4 of said Section 16, a distance of 14.70 feet; thence run S 00°20'04" E, a distance of 303.59 feet; thence run N 89°39'56" E, a distance of 14.70 feet to a point on the east line of the Northwest 1/4 of the Northeast 1/4 of said Section 16; thence run S 00°20'04" E, along the east line of the Northwest 1/4 of the Northeast 1/4 of said Section 16, a distance of 1018.49 feet to a point on the south line of the Northwest 1/4 of the Northeast 1/4 of said Section 16; thence run S 89°28'12" W, along said south line, a distance of 1327.34 feet to the POINT OF BEGINNING.

Containing a total of 192.92 acres, more or less.
