ACTION REQUESTED:

Approval to award Invitation for Bids Y19-772-TA, Town Center (PS 3497) and South Central (PS 3499) Master Pump Station Improvements, to the low responsive and responsible bidder, Intercounty Engineering, Inc., in the total contract award amount of \$9,719,700.

PROCUREMENT:

This project involves two master pump station improvements for pump station #3497 and #3499. The improvements include renewal and replacement of pump stations; rehabilitation of wet wells; piping, buildings, and miscellaneous equipment; reconfiguration of sewer system, installation of emergency generators, fuel tanks, odor control units, and electrical system; CCTV inspections; and lining for gravity mains. Sustainable components include the repairing of aging infrastructure and replacement of older equipment with new more energy efficient equipment. This project is located in Districts 1 and 4.

FUNDING:

Funding is available in account number 4420-038-1559-6310.

APPROVALS:

The Utilities Engineering Division and the Business Development Division concur with this recommendation.

REMARKS:

Three bids were received in response to the Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. Intercounty Engineering, Inc. has a satisfactory record of performance and is considered responsible. Therefore, award is recommended to Intercounty Engineering, Inc.

Master Pump Station Improvements

The Business Development Division evaluated the three bids submitted for this project. None of the bidders was an Orange County certified Minority/Women Business Enterprise. The scope of services for this project had Minority/Women Business Enterprise availability. At the time of bid opening, at least 66 M/WBE firms were certified to provide the scope of services at the subcontract level.

The apparent low bidder, Intercounty Engineering, Inc., did not achieve good faith effort documentation. While the low bidder reported \$1,946,761.94 in M/WBE participation, they did not specify the work to be performed on attachment C-2. Therefore, the M/WBE participation could not be confirmed.

The second low bid, submitted by Prime Construction Group, Inc., did not achieve good faith effort documentation and reported 8.87% M/WBE participation in their bid.

The third low bid, submitted by Sawcross, Inc., did not achieve good faith effort documentation and reported 18.31% M/WBE participation in their bid.

None of the bids met the M/WBE sliding scale range criteria to be awarded this contract over the low bidder.
