#### REMARKS:

Seven bids were received in response to this Invitation for Bids (IFB) and were evaluated for price, responsiveness, and responsibility. Concrete Lion Pictures, LLC, CSK Creative, LLC, and Fiat Luxx Productions was deemed non-responsible due to submitting bids that did not meet the requirements specified in the IFB. Price reasonableness was determined through competitive solicitation process. Convention News Television, LLC has a satisfactory record of performance and is considered responsible. Therefore, award is recommended to Convention News Television, LLC.
