## **RE:** Public Hearing for Board Meeting on June 17, 2025

Ordinance pertaining to nuisances in Orange County, Florida; amending Chapter 28 of the Orange County Code ("Nuisances") to create Article VI, ("Fireworks"); adding new Sections 28-128 through 28-140 related to the use and discharge of fireworks; providing definitions; providing scope of territorial application; providing prohibitions; providing exemptions; providing responsibility for noncompliance; providing for enforcement; providing for appeals; providing penalties; and providing an effective date.

#### I. EXPLANATION & SUMMARY:

The Board of County Commissioners ("Board") conducted a Work Session on May 20, 2025, to consider a proposal for an ordinance as a potential solution to provide for effective enforcement against the illegal use of fireworks. At the end of the Work Session, the Board directed the Orange County Attorney's Office to prepare a draft ordinance related to the use of fireworks and to present the draft ordinance to the Board for consideration at a public hearing on June 17, 2025. The proposed Fireworks Ordinance is attached for the Board's consideration and discussion at the June 17th public hearing.

The purpose of the proposed Fireworks Ordinance is to provide for effective enforcement of the State's prohibitions against the illegal use of fireworks. Therefore, the proposed ordinance incorporates into the Orange County Code of Ordinances the State's prohibitions against the illegal use fireworks in Chapter 791, Florida Statutes. > fireworks as provided in Chapter 791; provides for enforcement against the illegal use of fireworks; and provides for abatement of the illegal use of fireworks as a nuisance. The proposed ordinance will be effective within the unincorporated and incorporated areas of the County.

#### **II. ACTION REQUESTED:**
