Case: Planning and Zoning Commission , Case # RZ-19-05-009; June 20, 2019
Consideration: This request is to consider a rezoning of 0.54 gross acres located at 2712 Alamo Drive; or generally located on the west side of Alamo Drive, approximately 50 feet south of W. Michigan Street from R-1A (Single-Family Dwelling District) to R-2 (Residential District) for the development of up to two (2) single-family detached dwellings, (two) 2 duplexes or a combination thereof, pending an approved lot split. Additionally, a variance from Orange County Code Section 13-1501 is requested to allow for a minimum lot width of 60 feet, in lieu of the required 80-foot lot width in the R-2 zoning district for attached two-dwelling unit structures (duplexes).
Location: District 3; located at 2712 Aloma Drive; or generally located on the west side of Aloma Drive, approximately 50 feet south of W. Michigan Street; Orange County, Florida (legal property description on file at Planning Division-see the vicinity map on reverse side)
