Managerial Appointment – Public Works Department

I am pleased to announce the appointment of Dale V. Mudrak, P.E. as the manager of the Development Engineering Division. This Division is responsible for review, permitting and construction inspection of residential and commercial development infrastructure which includes new roadways, intersections, sidewalks and drainage projects. The Division also completes plan reviews for all Development Review Committee projects and issues various development related permits. Mr. Mudrak has served as interim manager since February 2021. He began his career initially with Orange County as an Engineer in 1987 at Public Works and left the County as a Senior Engineer for Parks & Recreation in 2002. He returned to Orange County in 2018 and was a Senior Engineer when assigned as the interim manager.

Mr. Mudrak has over 35 years of experience in civil engineering including project management, road and intersection design and permitting, construction of streetscape, pedestrian facilities, trails and bridges, and contract management. Mr. Mudrak has worked for a broad range of both public and private sector entities.

Mr. Mudrak holds a bachelor's degree in Civil Engineering from the University of Central Florida and holds a Professional Engineer License in Florida. He also is a Florida Certified Building Contractor, holds certificates in erosion control, trench shoring and advanced maintenance of traffic, and is a professional member of the American Society of Civil Engineers.

Mr. Mudrak's appointment will be effective February 9, 2022, upon Board approval at an annual salary of \$127,004.80. His resume is attached for your reference.

Job responsibilities include the oversight of the following Division Sections: Plan Review, Permitting, Platting, and Inspection. In the past fiscal year, the Division has issued approximately 3,550 right-of-way permits, 70 mass grading/excavation/fill permits, 2,570 commercial site permits, reviewed 250 subdivision plans, approved over 6,000 lot grading plans, and conducted approximately 30,000 inspections. Implemented a training program for all Review Sections. Supervision of 42 administrative, technical and field personnel.

March 2020 – February 2021, Senior Engineer, Highway Construction Division

Job responsibilities include attending and running pre-construction meetings, performing inspections, project conflict resolution, plan review, change-order negotiations, citizen concerns and project close outs.
