### **ACTION REQUESTED:**

Approval of Contract Y24-2012, Provision of Community Services and Facility Use, with Florida Economic Consortium, Inc., in the total contract award amount of \$225,000 for a three-year term.

# **PURPOSE:**

This contract will provide funds for reading/math coaches – sector 1 to assist students (kindergarten through eighth grade) who are struggling with reading and mathematics to ensure they are at the appropriate level of skill. The performance period is January 1, 2024 through December 31, 2026.

#### **FUNDING:**

Funding is available in account number 0001-062-2556-8610.

#### APPROVALS:

The Citizens' Review Panel for Human Services (CRP) recommended Florida Economic Consortium, Inc. to receive CRP funding to provide these services. The Citizens' Commission for Children Division concurs with the funding recommendation. Florida Economic Consortium, Inc. has previously received funding from the Citizens' Commission for Children Division.
