Medicaid Reimbursement

- Due to stagnant rates of Medicaid reimbursements, Florida Hospitals have faced challenges in providing millions of dollars of uncompensated care to persons who qualify for Medicaid
 - Historically Medicaid has typically only covered approximately 60% of costs of health care services provided to Medicaid patients.
 - Recent data shows that local hospitals incurred roughly \$470 million in uncovered Medicaid costs in a single year.

Background

- In April of 2021, the Centers for Medicare and Medicaid Services ("CMS") approved the Florida Agency for Health Care Administration's ("AHCA") proposal for a Statewide Medicaid Managed Care hospital directed payment program (DPP)
- The Directed Payment Program (DPP) is intended to help offset hospitals' uncompensated Medicaid costs and improve quality of care provided to Florida's Medicaid population
- Support provided to the hospitals translates to greater medical care for patients and opportunities for hospitals to further address community care gaps



Background

BCC Approved Ordinance 2021-35 on August 24, 2021

- Authorizes a non-ad valorem special assessment to be imposed against private for-profit and not-for-profit hospital properties located within Orange County
- Provides that proceeds be used only to benefit assessed hospital properties through enhanced Medicaid reimbursements for healthcare services provided to Medicaid-eligible population
- Assessment does not financially impact the County or the County's residents

- Adopted annually in accordance with Sec. 125.01, Florida Statutes and the Orange County Local Provider Participation Fund Ordinance, codified at Article XI, Chapter 25 of the Orange County Code of Ordinances
- Authorizes the Board to impose a special assessment against private for-profit and not-for-profit hospital
- The non-ad valorem special assessment shall be imposed, levied, collected, and enforced against Assessed Properties located within the County



- Assessment is computed and assessed according to a formula established under federal regulations and derived from hospital cost reports and reports from AHCA
- Once imposed, the assessment constitutes a lien upon the assessed property equal in rank and dignity with liens of all state, county, district, or municipal taxes and other non-ad valorem assessments
- Failure to pay may lead to foreclosure, resulting in loss of title



- Comptroller administers the special assessment
- Funds generated by the assessment are held in a separate fund, called the Local Provider Participation Fund (LPPF)
- Funds are only to be used to provide AHCA the non-federal share for Medicaid payments in support of hospitals serving Medicaid and low-income patients and to reimburse administrative costs (not to exceed \$150K) The Comptroller currently receives the \$150,000 to administer this program.



- Federal regulations require the assessment to be:
 - Broad-based applied to all providers within the County's jurisdiction
 - Uniformly imposed tax imposed at a uniform rate
- The Hospitals shall pay to the County the full assessment promptly upon the passing of this Resolution, but in no event later than December 31, 2023



- Assessment shall equal 2.18% of hospital net patient revenue for each Assessed Property identified in the Non-Ad Valorem Assessment Roll
- There is a limit on the amount of federal match the State can pull down, which
 is why there is still a gap or unfunded amount that the hospital cover for
 Medicaid patients
- After DPP Program, Medicaid typically covers 83% of the costs of health care services provided to Medicaid patients

Requested Action

- Approval of Consent Agenda Item D8 Budget Amendment #23-54
 - Budget Amendment Necessary to increase the LPPF budget established for FY 22/23 by \$41,836,132 to pay the total amount of \$207,355,680 that will be collected by the county through the LPPF assessments to the AHCA.
 - The State will receive the federal match and make payments to Medicaid managed care organizations providing healthcare service to Medicaid, Indigent and uninsured members of the Orange County Community.
