

NOTICE OF PROPOSED ENACTMENT

On May 17, 2021, the Orlando City Council will consider proposed ordinance #2021-30, entitled AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ORLANDO, FLORIDA, ANNEXING TO THE CORPORATE LIMITS OF THE CITY CERTAIN LAND GENERALLY LOCATED EAST OF BOGGY CREEK ROAD, SOUTH OF LAKE NONA BOULEVARD AND NORTH OF KINGDOM ROAD, ADDRESSED AS 14041 BOGGY CREEK ROAD AND COMPRISED OF 7.54 ACRES OF LAND, MORE OR LESS, AND AMENDING THE CITY'S BOUNDARY DESCRIPTION; AMENDING THE CITY'S ADOPTED GROWTH MANAGEMENT PLAN TO DESIGNATE THE PROPERTY AS URBAN VILLAGE ON THE CITY'S OFFICIAL FUTURE LAND USE MAPS; AMENDING THE BOUNDARIES OF GROWTH MANAGEMENT PLAN SUBAREA POLICY S.35.4 TO INCLUDE THE PROPERTY IN THE SOUTHEAST ORLANDO SECTOR PLAN; PROVIDING FOR AMENDMENT OF THE CITY'S OFFICIAL FUTURE LAND USE MAPS; PROVIDING FOR SEVERABILITY, CORRECTION OF SCRIVENER'S ERRORS AND AN EFFECTIVE DATE.
