ACTION REQUESTED:

Approval of Contract Y24-2002, Provision of Community Services and Facility Use, with Boys and Girls Clubs of Central Florida, Inc., in the total contract award amount of \$300,000 for a three-year term.

PURPOSE:

This contract will provide funds for youth mentoring – sectors 1 and 2. Program services will be provided to Orange County youth up to age 17 years or completing the 12th grade and will include one-on-one mentoring, group mentoring, social-emotional learning activities, mental health activities, and advocacy. The performance period is January 1, 2024 through December 31, 2026.

FUNDING:

Funding is available in account number 0001-062-2556-8610.

APPROVALS:

The Citizens' Review Panel for Human Services (CRP) recommended Boys and Girls Clubs of Central Florida, Inc. to receive CRP funding to provide these services. The Citizens' Commission for Children Division concurs with the funding recommendation. Boys and Girls Clubs of Central Florida, Inc. has previously received funding from the Citizens' Commission for Children Division.

REMARKS:

In accordance with the Code of Ordinances, Part 1, Chapter 17, Article III, Section 17-286 – Application and Exclusions, agreements between the Board and nonprofit organizations are excluded from competitive procurement requirements.

The goal of the program is to have an emphasis on a mentoring component based on best practices, dedicated staff, and agency support to achieve successful program outcomes including, but not limited to increased graduate success, prevention or reduction of anti-social, delinquent, or destructive behaviors, and reduction of delinquent recidivism. The program shall promote behaviors, attitudes, and outcomes for youth and reduce risk factors.

The agency anticipates serving an estimated 130 unduplicated participants per year. Services will be provided at the following locations:
