ACTION REQUESTED:

Approval and execution of First Amendment to 2026 Sculpture on the Lawn Agreement Between Orange County, Florida and Graphic Content, Inc. (Arts and Cultural Affairs Office)

PROJECT: N./A

PURPOSE: Once a year our office extends an international artist call for the loan of sculptures for the yearlong *Sculpture on the Lawn* exhibition; subsequently, the Public Art Review Board chooses the four sculptures to be installed outside of the Orange County Administration Center. The mission of the Public Art Review Board is to include public art in Orange County for the benefit and education of its citizens while enhancing the visual environment through a diversity of styles, content, and artists. This sculpture was delayed in its' arrival at the Administration Building due to complications with the artist obtaining his sculpture from storage. Therefore, the term of the agreement has changed to commence between May 1, 2026 and May 31, 2026. The remainder of the contract will not change.

BUDGET: The artist receives \$5,000

THIS FIRST AMENDMENT, is made and entered into this 5th day of May, 2026 by and between Orange County, a charter county and political subdivision of the State of Florida (“County”) and Graphic Content, Inc., a corporation (“Lender”).

RECITALS

WHEREAS, the County and Lender entered into a sculpture loan and display agreement on October 28, 2025 (“Agreement”) for the loan of the Sculpture entitled “Human Nature Figure, 5-6-7” (Sculpture) depicted in Exhibit A to the Agreement; and

WHEREAS, the term of the Agreement originally agreed upon by the parties to commence in January 2026 and conclude in January 2027;

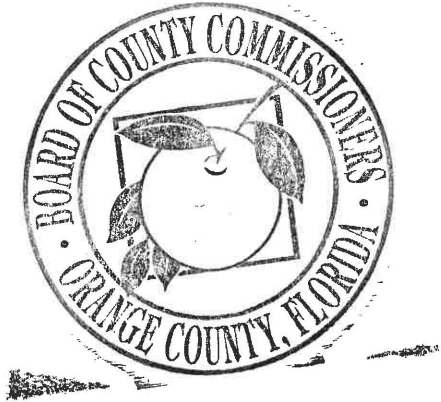
WHEREAS, because of delays in obtaining the Sculpture, the commencement of the term of the Agreement requires adjustment.

NOW THEREFORE, in consideration of the premises and mutual covenants herein contained, the parties agree as follows:

1. **Amendments to Agreement.** Section 2 of the Agreement is hereby amended as follows with additions being underlined and deletions ~~struck through~~:
 2. **Term.** The term of the Agreement shall commence on a date no earlier than May ~~January~~ 1, 2026, and no later than May ~~January~~ 31, 2026; and shall terminate no earlier than January 1, 2027, and no later than January 31, 2027.
2. **Remainder of Agreement Unchanged.** Except as otherwise set forth herein, the remainder the Agreement shall remain unchanged and in full force and effect.
3. **Effective Date.** This First Amendment shall become effective upon the later of execution by County or the date of execution by Lender.
