Approval to award Invitation for Bids Y20-1037-WA, Purchase of Visualization Table, to the low responsive and responsible bidder, Anatomage, Inc., in the total estimated contract award amount of \$125,960.

PROCUREMENT:

The contract will provide a visualization table, including five years of warranty and maintenance, for the Medical Examiner's Office. The visualization table receives Digital Imaging and Communications in Medicine computerized tomography (CT) images pulled from a locally installed workstation and picture archiving and communication system to the table. The table will display data provided by CT scans in several modalities. It will provide 2D, 3D renderings, ability to annotate, segment or overlay tissue reconstruction, and 3D reconstruction.
