

# RESOLUTION

## ORANGE COUNTY BOARD OF COUNTY COMMISSIONERS

*regarding*

**DECLARING THE COUNTY'S OFFICIAL INTENT TO REIMBURSE ITSELF FROM THE PROCEEDS OF TAX-EXEMPT OR OTHER TAX-ADVANTAGED OBLIGATIONS FOR CERTAIN CAPITAL EXPENDITURES TO BE MADE BY THE COUNTY WITH RESPECT TO THE FINANCING OF CERTAIN COSTS AND REPAYMENT OF INTERFUND LOANS RELATING TO THE ACQUISITION, CONSTRUCTION, AND EQUIPPING OF CAPITAL IMPROVEMENTS TO ITS EXISTING WATER AND WASTEWATER FACILITIES; AUTHORIZING CERTAIN INCIDENTAL ACTIONS; AND PROVIDING FOR AN EFFECTIVE DATE.**

**RESOLUTION NO. 2024-\_\_ - \_\_\_\_\_**

**WHEREAS**, in connection with the acquisition, construction, and equipping of certain capital improvements to its existing water and wastewater facilities, as more particularly described on **Exhibit “A”** hereto (collectively, the “Project”), Orange County, Florida (the “County”) has incurred and/or will incur various costs for which the County plans to use a combination of cash on hand as well as amounts derived from interfund loans to temporarily pay for the costs of the Project; and

**WHEREAS**, the County has determined it is in its best interest to reimburse itself for such costs from proceeds of one or a combination of short-term notes or tax-exempt debt, and to reimburse itself for costs incurred with respect to the Project prior to the issuance of such debt (collectively, the “Debt Obligations”); and

**WHEREAS**, the Internal Revenue Code of 1986, as amended, and applicable regulations require the County to declare its official intent in connection with such expenditures prior to incurring the Debt Obligations in order to allow the County to be reimbursed for such expenditures from a portion of the proceeds of the Debt Obligations; and

**WHEREAS**, it is intended by the County that this Resolution constitute a declaration of official intent with respect to the reimbursement, from proceeds of the Debt Obligations, of those

certain capital expenditures incurred or to be incurred by the County for the Project prior to the issuance of the Debt Obligations.

**BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ORANGE COUNTY:**

***Section 1. Incorporation of Recitals.*** The recitals set forth above are adopted by the County as the findings of the County and are incorporated herein.

***Section 2. Authority.*** This Resolution is adopted pursuant to the provisions of the Constitution of the State of Florida, Chapter 125, Florida Statutes, the Charter of the County, and other applicable provisions of law.

***Section 3. Declaration of Official Intent.*** The County hereby declares its official intent to reimburse itself from the proceeds of Debt Obligations expected to be issued by the County for expenditures incurred with respect to the Project and to be incurred subsequent to the date of this Resolution, subject to Treasury Regulation § 1.150-2. This Resolution is intended as a declaration of official intent under Treasury Regulation § 1.150-2. The Debt Obligations to be issued to finance the Project are expected not to exceed \$140,000,000 aggregate principal amount. The County has paid for and/or reasonably anticipates that it will pay for, such costs and expenditures from moneys on deposit in the Water & Wastewater System Fund of the County including, but not limited to, amounts deposited therein as a result of interfund loans. The expenditures to be reimbursed shall be consistent with the County's budgetary and financial policy as being the type of expenditures which shall be paid on a long-term basis.

***Section 4. Nature of Project Costs.*** The County will certify that costs of the Project expected to be reimbursed consist entirely of capital expenditures or, as applicable, costs of issuance of tax-exempt bonds, and no cost of the Project to be reimbursed with the proceeds of the Debt Obligations is a cost of working capital.

**Section 5. Applicable Law.** The County shall comply with all applicable laws in regard to the public availability of records of official acts by public entities such as the County, including making the Resolution available for public inspection.

**Section 6. Incidental Action.** The appropriate officials and staff of the County are hereby authorized to take such actions as may be necessary to carry out the purpose of this Resolution.

**Section 7. Effective Date.** This resolution shall take effect immediately upon its adoption.
