ORDINANCE NO. 2000-23

AN ORDINANCE AMENDING CHAPTER 33, SPECIAL DISTRICTS, PART 1, LAKE CONWAY WATER CONTROL AND NAVIGATION DISTRICT BY AMENDING SECTION 38-48 "ADVISORY COMMITTEE; CREATION, FUNCTION, MEMBERSHIP." BY CHANGING THE NUMBER OF MEMBERS TO SEVEN; PROVIDING FOR CURRENT MEMBERS TO REMAIN IN OFFICE DURING THEIR TERM; PROVIDING FOR SEVERABILITY, AND PROVIDING FOR AN EFFECTIVE DATE AND CODIFICATION.

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF ORANGE COUNTY, FLORIDA:

Section 1. Chapter 33, Special Districts, Part I, Lake Conway Water Control and Navigation District, Section 33-48, Advisory committee; creation, function, membership, Ordinance of the Orange County Code is amended as set forth below. Except as may be expressly noted, additions shall be shown by underlines and deletions shall be shown by strike-throughs.

Sec. 33-48. Advisory, committee; creation, function, membership.

For the purpose of assisting and advising the board of county commissioners there is hereby created an advisory committee. There shall be three (3) seven (7) members of said advisory committee to be appointed by the board from among the resident free-holders within said district for a term of two (2) years, and the said members shall serve without any compensation or remuneration whatsoever. Vacancies occurring on said committee shall be promptly filled by the board.

Section 2. Existing Committee Members. Current members of the Advisory

Committee, whether appointed pursuant of Section 33-48 or pursuant to subsequent resolution, shall remain in office pursuant to their appointment as long as they are otherwise qualified.

Section 3. Severability of provisions. If any provision of this ordinance or the application thereof to any person or circumstance is held invalid, the invalidity shall not affect other provisions or applications of this ordinance which can be given effect without the invalid provision or application and, to this end, the provisions of this ordinance are declared severable.

Section 4. Effective date; codification. This ordinance shall take effect pursuant to general law. Only the provisions of Section 1 shall be codified, but the provisions of Sections 2, 3, and 4 shall remain in full force and effect after codification.
