### ACTION REQUESTED:

Approval of commercial refuse license for Load & Go Dumpsters, Inc to provide solid waste hauling services to commercial generators in Orange County for a five-year term. All Districts. (Solid Waste Division)

**PURPOSE:** The Solid Waste Division has received a commercial refuse license application from Load & Go Dumpsters, Inc, to provide solid waste hauling services to multi-family, construction and demolition, and other commercial generators in Orange County.
