ACTION REQUESTED:

Approval to award Invitation for Bids Y23-778-RC, Clerk of Courts Winter Park Courthouse at Metric Drive, to the low responsive and responsible bidder, Poli Construction Inc. in the total contract award amount of \$12,008,843.00 inclusive of Alternate Number 1.

In the event the bidder recommended above fails to achieve timely compliance with preaward deliverables, as defined in the Invitation for Bids, including, but not limited to, State Division of Corporations registration, E-Verify, insurance and bonds, further request authorization for the Procurement Division to award to the next low responsive and responsible bidder as listed in the bid tabulation herein, to the extent practicable and advantageous to the County.

PROCUREMENT:

The project consists of Florida Building Code, level 3, renovation of an existing, single-story 33,915 square foot building and related site improvements. Work shall consists of site and civil upgrades, landscape, interior demolition of the existing architectural, and Mechanical Electrical Plumbing (MEP) systems and the new interior buildout of all architectural, limited structural upgrades, and MEP systems to accommodate the following, including, but not limited to, public entry and security screening, two court rooms, holding cell, restrooms, public waiting areas, jury assembly and deliberation rooms, judges' chambers, clerk of courts public waiting area, clerk of courts public service counter, and administrative support areas. Alternate Number 1 will require the bidder to, in lieu of the decorative aluminum fence and remote operated gates in the secure parking area, provide a concrete masonry unit enclosure with stucco finish and metal coping; galvanized hollow metal doors, and frames with associated door hardware; access control devices; and composite wood fence system. The project is located in District 5.

The Capital Projects Division and Business Development Division concur with this recommendation.

REMARKS:

Three bids were received in response to the Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. The bid submitted from Poli Construction Inc. is considered reasonable based on comparison to the engineer's estimate. References provided were satisfactory for this type of work and Poli Construction Inc. has been determined to be responsible. Therefore, award is recommended to Poli Construction Inc.

The Business Development Division evaluated three bids submitted for this project. The Business Development Division completed a M/WBE Availability Analysis. The scope of services for this project had M/WBE availability. As a result, the M/WBE goal remained at 25%. At the time of bid opening; at least 149 firms were certified to provide the scope of services at the subcontract level.

The apparent low bid, submitted by Poli Construction, Inc., reported 26.32% in M/WBE participation. The apparent low bid met the Orange County M/WBE participation goal **per the Ordinance requirement.** Please note the following certified M/WBE participation:

The second low bid, submitted by CIC Construction Group USA, LLC, reported 31.23% in M/WBE participation. The second low bid met the Orange County M/WBE participation goal **per the Ordinance requirement.** Please note the following certified M/WBE participation:

The third low bid, submitted by Oelrich Construction, Inc., reported 24.53% in M/WBE participation. The M/WBE participation doesn't meet the Orange County M/WBE participation goal of 25% per the Ordinance requirement.
