ACTION REQUESTED:

Approval to award Invitation for Bids Y18-717-TA, Utilities West Area Force Main Improvements-Package 1, to the low responsive and responsible bidder, PWC Joint Venture, LLC for the estimated contract award amount of \$1,388,867.21.

PROCUREMENT:

The improvements include the removal of approximately 4,900 linear feet of existing 8-inch force main and 2,000 linear feet of 16-inch force main and the installation of 1,200 linear feet of 6-inch diameter PVC force main and 3,000 linear feet of 16-inch PVC and HDPE diameter force main. This project is located in District 1.

FUNDING:

Funding is available in account number 4420-038-1539-32-6345.

APPROVALS:

The Utilities Engineering Division and the Business Development Division concur with this recommendation.

REMARKS:

Eight bids were received in response to the Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. Valencia Construction Group was determined to be non-responsible due to their references not meeting the bid requirements. PWC Joint Venture, LLC has a satisfactory record of performance and is considered responsible. Therefore, award is recommended to PWC Joint Venture, LLC.

The Business Development Division evaluated the 3 lowest bids of the 7 bids submitted for this project and found that the apparent low bidder PWC Joint Venture, LLC met the MWBE participation goal and reported 27.74% MWBE participation in their bid. Please note the following certified MWBE participation:

The second low bid submitted by Schuller Contractors Incorporated did not achieve good faith effort documentation and reported 14.97 % MWBE participation in their bid.

The third low bid submitted by Carr & Collier, Inc. (fka Villages Construction, Inc.) met the MWBE participation goal and reported 25.02% MWBE participation in their bid.

None of the bids were within the MWBE sliding scale range to be awarded this contract over the low bidder.

Our evaluation of these bids was based on the participation listed on the subcontractor/supplier page. If the low bidder is not chosen, please let us know so that we may obtain Letters of Intent to confirm the participation.
