Business Assistance for Neighborhood Corridors (BANC)

Program

The Neighborhood Services Division administers the Business Assistance for Neighborhood Corridors (BANC) Program, which provides resources for economic development in targeted corridors. In 2012, the Board approved the BANC Program to revitalize once thriving commercial corridors that suffer from a lack of investment and are deficient of financial support. The BANC Program reimburses businesses, located on designated corridors, for costs associated with improving the business site. Some of the allowable projects are façade improvements to the structure, conventional rezonings, demolition costs, and bringing a structure up to code. To date, the program has been successful in revitalizing the designated corridors with facade and regulatory improvements.

Based on the age of the BANC Program and because certain components of the program have shown to be barriers for successful implementation, staff conducted a comprehensive review of the program to identify appropriate changes. Utilizing Geographic Information System (GIS) for mapping and data from InfoUSA, staff objectively analyzed the corridors most appropriate for eligibility in the program. Additionally, staff reviewed program components and determined that the \$5,000 façade improvement reimbursement for small businesses is inadequate.

To create a more effective program, staff recommends increasing the eligible amount a business can receive to \$10,000, with a 5% match requirement. Additionally, instead of issuing a reimbursement, payments will be made directly to the selected vendor.
