Greetings Rolling R Ranch Ltd,

The Orange County Board of County Commissioners recently invigorated the County's natural lands preservation program known as Green PLACE by allocating 100 million dollars towards preserving natural lands in Orange County.

Green PLACE stands for Park Land Acquisition for Conservation and Environmental Protection and is an initiative to preserve, enhance, and restore environmentally sensitive lands. This program encourages the establishment of regional corridors, greenways, and blueways.

The Green PLACE program's focus is the preservation of its environmentally sensitive lands and the management and enhancement of those preserved areas through the use of controlled burning, invasive species and forestry management. Preservation of environmentally sensitive lands is an important tool used by federal, state, local, and private organizations to preserve natural resources, to protect non-imperiled and imperiled wildlife and plant species, provide nature-based recreational opportunities, and to provide wildlife corridors for species that require a large geographic distribution.

Preservation of Orange County natural resources provides ecological, economic and social benefits and will ensure that Orange County remains a sustainable community for current and future generations.

Currently, Green PLACE has preserved over 23,000 acres of environmentally sensitive areas independently or in partnership with State and local entities. To date, Orange County has opened 13 of these preserved areas for nature-based recreational opportunities such as hiking, horseback riding, wildlife observation, fishing and canoeing and kayaking.
