## **RECOMMENDATION:**

Selection of SGM Engineering, Inc. to provide Design Services for the Orange County Convention Center Campus Dry Sprinkler Replacement, Request for Proposals Y20-801-JS. Further request authorization for the Procurement Division to negotiate and execute the final contract within a budget not to exceed \$890,000.

This item was evaluated by the Procurement Committee on September 25, 2019. Commissioner Christine Moore was assigned to the Procurement Committee.

## **PURPOSE:**

To select a firm to provide design services for the campus dry sprinkler replacement at the Convention Center.

## **DISCUSSION:**

The Consultant shall provide final design and construction plans for the Convention Center Campus Dry Sprinkler Pipe Replacement project. The Consultant shall perform those architectural and/or engineering services required to prepare a complete set of contract documents, plans, and specifications.
