Approval of the Subcontract Amendment #10 for provision of Children In Need of Services and Families In Need of Services

(CINS/FINS)

On July 29, 2014, the Board approved the original contract between the Florida Network of Youth and Family Services (Florida Network) and Orange County to provide CINS/FINS services through the Orange County Youth Shelter and Family Counseling Program. This contract has been renewed and has had programs added through nine previous amendments. The contract is currently renewed through June 30, 2024, with a total contract amount not to exceed \$7,966,058.75.

The contract with Florida Network provides funding to deliver residential and nonresidential services to CINS/FINS as outlined in Chapter 984, Florida Statutes. These services include, but are not limited to: Centralized Intake, Outreach, Screening and Referral, Assessment, Service Planning, Case Management, Temporary Shelter, Counseling, Case Staffing Committee, and Adjudication Services. The goal of these prevention services is to strengthen families and prevent juvenile crime and child abuse. At risk youth will be served by providing a continuum of services to include short term shelter, counseling, and case management. Youth who qualify are not currently delinguent or dependent.

The purpose of this amendment is to formalize a pre-existing and ongoing arrangement where the general counsel's office of the Florida Department of Juvenile Justice serves as legal counsel for the County in CINS/FINS matters brought by the County pursuant to the contract and Florida law. Approval of this amendment will formally grant the Florida Department of Juvenile Justice the authority to: CINS/FINS petitions in the Juvenile Division of the Circuit Court on behalf of Orange County and represent Orange County before the court regarding the proceedings foreseeably flowing from filing of CINS/FINS petitions.

Subcontract Amendment #10

The purpose of this Amendment is to update the Scope of Services of this agreement.

The SUBCONTRACT AGREEMENT between the **Orange County, Florida** on behalf of its Youth and Family Services Division and the **Florida Network of Youth and Family Services** is amended by deleting as indicated by "strikethrough" and adding as indicated by "underscoring" as follows.

REFERENCE: Attachment I Services to be Provided, III.A. Service Tasks

ADD:

9. The Orange County Board of County Commissioners officially grants to the Florida Department of Juvenile Justice the authority to: (1) file Child in Need of Services (CIN) or Family in Need of Services (FIN) petitions in the Juvenile Division of the Circuit Court on behalf of Orange County, Florida, so long as both the Manager of designee of the County's Youth and Family Services Division and the Florida Department of Juvenile Justice agree that the filing or such petition is an appropriate course of action; and (2) represent Orange County, Florida, before the court the proceedings foreseeably flowing from the filing of such CIN or FIN petitions by the Florida Department of Juvenile Justice. This stated authority: (1) runs with the duration of the underlying agreement between the parties and any renewals to such underlying agreement; and (2) may be rescinded by the Orange County Board of County Commissioners with written notice provided to the Florida Network of Youth and Family Services and the Florida Department of Juvenile Justice.

This amendment shall become effective August 1, 2019 or upon full execution. All terms and conditions of said original contract and any attachments and amendments thereto shall remain in full force and effect for this Amendment. Any provisions of said original Contract and any supplements and amendments thereto in conflict with this Amendment shall be and are hereby changed to conform to this Amendment. This Amendment is hereby made a part of the Contract.
