Further request the Board authorize the Procurement Division to negotiate and award a contract provided that it does not exceed the budget of \$1,430,500.

PURPOSE

This contract will provide engineering design services for Little Wekiva River-Lake Lotus Park Regional Stormwater Treatment Facility. This project is located in District 2.

DISCUSSION

The project is for engineering services for the final design of Little Wekiva River-Lake Lotus Park Regional Stormwater Treatment Facility. This project calls for an off-line treatment facility, including a wet detention pond, wetland treatment, and a Florida Department of Transportation retention pond. This will include intake/diversion structures and a discharge structure downstream of the facility to control the water exiting the facility. The design shall also include the construction or improvement of necessary access to the facility for maintenance.
