Consideration: A PD substantial change to request the following waivers from Orange County Code: 1) A waiver from Orange County Code Section 38-1258(c) to allow for a maximum building height of fifty-five (55) feet/four (4) stories for multifamily development in Parcel 6C, multitamily development in Parcel 6C, in lieu of a maximum building height of forty (40) feet/three (3) stories. 2) A waiver from Orange County Code Section 38-1254(2) (a) to allow for a minimum building setback of twelve (12) feet on the south side of J.
