#### **RECOMMENDATION:**

Selection of one firm and an alternate to provide Design Services for the Orange County Mosquito Control Facility, Request for Proposals Y20-820-RC, from the following firms, listed alphabetically. Further, request the Board to authorize the Procurement Division to negotiate and execute the final contract, provided that it does not exceed the budget of \$500,000.

- Architectural Design Collaborative, Inc.
- KMF Architects

The Procurement Committee evaluated proposals on August 19, Commissioner Betsy VanderLey was assigned to the Procurement Committee.

#### **PURPOSE:**

The purpose of this contract is to select a firm to provide design services for the Orange County Mosquito Control Facility.

#### DISCUSSION:

The project consists of design and construction administration services for the new Orange County Mosquito Control Facility. The new facility will be a 30,000 square foot or greater facility and include larger spaces than the county's original facility to address growth needs.

The Consultant will perform the following services:

- 1. Project Program Development
- 2. Project Data/Information Gathering
- 3. Design Development
- 4. Bidding Services
- 5. Construction Contract Documents
