**REMARKS:** 

On December 1, 2020, the Board approved the Option Agreement Regarding Wellness Way (Option Agreement) by and among Orange County, Florida, the City of Orlando (City) collectively (Conserv Partners) and Lake County, Florida, regarding property Conserv Partners jointly owns 50/50 in Lake County. Option Agreement grants Lake County an option to purchase certain Conserv Partners land required for a proposed four-lane extension of the existing Wellness Way right-of-way in Lake County, running in a general east-west alignment, extending from its current southern terminus at Five Mile Road to the proposed Wellness Way right-of-way. Pursuant to Option Agreement, Lake County sent notice to Conserv Partners that it will exercise the option to purchase the land for the right-of-way, and the road design requires a Drainage Easement and Temporary Construction Agreement.

City has executed its deed for its undivided 50 percent interest of the fee simple right-of-way, which includes the grant of the Drainage Easement and a Temporary Construction Easement.
