Background

On September 13, 2016, the BCC requested a work session to discuss the CFHLA's proposal to extend the hours of operation for sale and consumption of alcoholic beverages for hotels and restaurants.



Current Regulations

Section 4-3 of Orange County Code

- **Permits sale and consumption of alcoholic beverages from 11 a.m.- 2 a.m. of following day**
- **Exceptions:**
 - **Golf course may serve 7 a.m. to Sundown**
 - **Private function at banquet hall or convention facility with minimum 10,000 sq.ft. may serve 7 a.m.-3 a.m.**
 - **Private hotel guest room may serve 7 a.m.-3 a.m.**



Surrounding Communities

County	Allowable Hours of Service	Exceptions
Brevard	7 a.m.-2 a.m.	Dec. 31 st 7 a.m.-4 a.m.
Lake	7 a.m.-2 a.m.	Dec. 31 st 4 p.m.-2 a.m.
Osceola	7 a.m.-2 a.m., except Sunday 11 a.m.-2 a.m.	Very similar to OC. Golf course and hotel room hours to 7 a.m.- 2 a.m. Sunday only
Seminole	8 a.m.-2 a.m., except Sunday 11 a.m.-2 a.m.	None

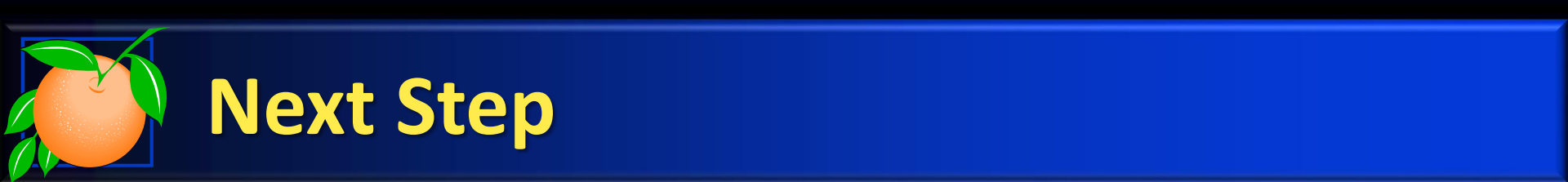
Municipality	Allowable Hours of Service	Exceptions
Apopka	9 a.m.-12 a.m., except Sunday 12 p.m.-12 a.m.	Dec. 31 st 12 a.m.-3 a.m.
Ocoee	11 a.m.-2 a.m.	None
Orlando	7 a.m.-2 a.m., except Sunday 9 a.m.-2 a.m.	Exempts airports and City venues from hourly limitations; Dec. 31 st 7 a.m.-3 a.m.
Winter Garden	7 a.m.-2 a.m., Restaurants 11 a.m.-2 a.m.	Dec.31 st 7 a.m.-3 a.m.
Winter Park	7 a.m.-11 p.m., except Sunday 11 a.m.-11 p.m.	Dec. 31 st 7 a.m.-1 a.m.; Westside Community 11 p.m. Sun-Thur. & 12 a.m. Fri-Sat



CFHLA Proposal

Key Changes Proposed to Section 4-3:

- **Revise (a)(1)-Replace golf course language with “private club with special club license”**
- **Revise (a)(3)-Change language which applies to “private guest room” to “public lodging establishments”**
- **Add language to allow restaurants to serve between 7 a.m.-2 a.m.**
- **Add new language allowing airports, theme parks and marine exhibition to serve between 7 a.m.-2 a.m.**
