ACTION REQUESTED:

Approval to award Invitation for Bids Y22-191-KK, Exterior Painting and Pressure Washing for Utilities Department, to the low responsive and responsible bidder, Directa, LLC, in the estimated contract award amount of \$262,032.50 for a one-year term. Further request authorization for the Procurement Division to renew the contract for four additional one-year terms.

PROCUREMENT:

This contract will provide exterior painting and pressure washing services for the Orange County Utilities Department.

FUNDING:

Funding is available in account numbers 4420-038-1301-3810, 4420-038-1310-3810, 4410-038-1359-3810, 4410-038-1013-3810, and 4410-038-1031-3810.

APPROVALS:

The Utilities Department and Business Development Division concur with this recommendation.

REMARKS:

Fifteen bids were received in response to this Invitation for Bids (IFB) and was evaluated for responsiveness, responsibility, and price reasonableness. MTD Painting & Construction Corp. was deemed non-responsive for failing to submit a written affirmation statement as required by the IFB.

Prices submitted were determined fair and reasonable based on comparison to current Orange County term contracts. All references for Directa, LLC, were verified as satisfactory. Therefore, award is recommended to Directa, LLC.

The Business Development Division evaluated the **14 bids** submitted for this project. **Three** of the bidders are Minority Business Enterprise (MBE) firms. At the time of bid opening at least seven firms were certified at the prime level in the scope of service. The **three** Orange County Certified Minority Business Enterprise firms **were not within 7%** of the low bid for bid awards greater than \$100,000 to \$500,000. Hence, the bid preference program in accordance with the County's M/WBE Ordinance, Section 17-324 cannot be applied.

Also, I confirm my recommendation is free of conflicts of interest.
